Vendor Rules and Responsibilities

- Table fee is \$15/spot(tent/canopy). VENDORS are to pay their table fee on each market day when the MARKET MANAGER collects on said day.
- VENDORS will need to provide their own tents, tables, and chairs for each market. If needed tables and chairs can be rented from the Bashaw Ag Society at a day rate of \$5/table/day and \$2/chair/day/
- VENDORS that are selling food products must have your proper food safety certifications, according to Farmer's Market Regulations, visible on your booth at every market. Also, the MARKET MANAGER must be provided with a paper copy of your certification at the first market you attend. All food products must be labeled correctly with all ingredients, as well as your business name and phone number.
- Bashaw Farmer's Market runs 4pm-7pm, as a vendor you are REQUIRED to stay until the market is over--no packing up 10min before market is over. This is in fairness to patrons arriving at the end of the market and fellow VENDORS. The only circumstance when this does not apply is if you have made previous arrangements with the MARKET MANAGER prior to the season beginning or emergencies.
Example: VENDOR has informed the MARKET MANAGER at the start of the season they can only be at market from 4 PM – 6 PM. In this case, this is allowed as long as the VENDOR keeps the same times and is consistent throughout the season.
- The market starts at 4 PM and ends at 7 PM. Please be set up 30 minutes prior to the market starting. The market will be open for selling when the bell is rung by the MARKET MANAGER. Respect these times and DO NOT sell before the bell rings. It is unkind to your fellow market VENDORS and causes a lot of confusion to our very supportive CUSTOMERS.
- Market is rain or shine. In the event of inclement weather the market may move indoors for that day. Not attending due to weather must be discussed with MARKET MANAGER and mutually agreed to.

- If you are unable to attend a market, please let the MARKET MANAGER know as early as possible—preferably at the beginning of the week—so vendor spots can be planned accordingly.
- Spots are not reserved for anyone and will be decided by the MARKET MANAGER. You might not be in the same spot every week. Seniority will be given to returning VENDORS who attend market consistently each week.
- Please remember that the Farmers Market is a family oriented event. You are required to act professionally and refrain from using inappropriate language during the market with CUSTOMERS or other VENDORS as this not only reflects on you but on the market as a whole.
- Make sure that you are look presentable and are dressed appropriately.
- Bullying and harassment of fellow VENDORS, MARKET MANAGER and CUSTOMERS will not be tolerated. This includes, but is not limited to, inappropriate/derogatory comments or conduct towards others, intimidation, physical and/or verbal threats or abuse, and vandalizing of another’s property.
- Any issues that arise between VENDORS and CUSTOMERS will be recorded and discussed with MARKET MANAGER to try and resolve issue. If the issue cannot be resolved or directly involves the MARKET MANAGER, it will go to the Bashaw and District Agricultural Society’s Board of Directors to discuss and come to a resolve.
- There is a “2-Strike Policy”. You will be notified verbally and in writing that you have violated market rules. After two violations the VENDOR will be asked to leave the market and will not be allowed to participate for the remainder of the season.
